# PRIVACY POLICY

## What We Collect – And Why

The website <https://top10casino.gr> **does not collect personal data**. There are no contact forms, no account creation, and no direct user data submission.

The only information processed is through the use of **essential cookies** required for the technical functioning of the website. These cookies:

- Enable basic website operations (e.g., language preferences, secure connection handling);
- Do not identify individual users;
- Are not used for tracking, profiling, or advertising purposes.

We do not collect sensitive personal data (such as health, biometric, political, or financial information).

**Voluntary submissions:** although this website does collect personal data, you may choose to provide us with personal information (e.g., by contacting us by email). In such cases, the data will be processed solely for the purpose of handling your inquiry and will not be used for any other purpose.

## Cookies & Technical Data

We rely exclusively on **essential cookies** to keep the site running.

- No third-party advertising cookies are used.
- No behavioral or cross-site tracking is performed.
- Optional analytics are not implemented at this time.

If our use of cookies changes in the future, we will update this notice accordingly and, if required, provide a consent mechanism.

You may control or disable cookies through your browser settings. Please note that disabling essential cookies may affect the proper functioning of the website.

## Legal Basis for Processing

Although we do not process personal data, the minimal use of essential cookies falls under our **legitimate interest** in ensuring the secure and reliable operation of our website.

## International Data Transfers

We do not transfer personal data internationally because none is collected. Hosting services may involve technical operations outside the EU/EEA. In such cases, providers are selected with due regard for GDPR-compliant safeguards.

## Data Retention

Since no personal data is collected, no data is retained beyond what is strictly necessary for the temporary functioning of cookies or server logs required for security and operational purposes.

However, in the event that you voluntarily provide us with personal data (for example, by contacting us by email), such data will be used solely for the purpose of handling your inquiry. It will be retained only as long as necessary to resolve your request and will be securely deleted within 90 days after the matter is closed, unless longer retention is required by law.

If our communication develops into a contractual relationship, the collection and retention of personal data will be based on the necessity of performing that contract under Article 6(1)(b) GDPR and subject to the applicable contractual and statutory requirements.

## Your Rights

Because no personal data is collected through this website, most GDPR rights (e.g., access, correction, deletion) do not apply.

However, in the event that you voluntarily provide us with personal data (for example, by contacting us by email), you retain the following rights under the GDPR:

- Access any data we hold about you
- Request correction of inaccurate information
- Ask for deletion of your data ("right to be forgotten")
- Restrict or object to certain uses of your data
- Receive your data in portable format (if applicable)
- Withdraw consent at any time
